(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors presented the clinical report from a cirrhotic patient presenting upper GI bleeding in which an infrequent communication was found between the left spermatic</p>	[Y]

vein and the SMV. The abstract, discussion and illustration of this manuscript need to be revised. There are also some issues with abbreviations to be aware of. The English level of the report is acceptable, but minor modifications are needed. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 21 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Letpub was provided. 3 Academic norms and rules: The authors provided the written informed consent and the CARE Checklist-2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by High-level Hospital Construction Research Project of Maoming People's Hospital. The topic has not previously been published in the WJGS. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that

	<p>all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report and the full text of the manuscript, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
