2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of the extracellular vesicles as mediators of alloimmunity and their therapeutic potential in liver transplantation. The topic is within the scope of the WJT. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: This is an excellent review of the use of extracellular vesicles in liver transplantation. However, there is very little information about the composition of the EV</p>	[Y]

cargo in terms of pro- and anti-inflammatory molecules and whether this can be exploited as a therapeutic avenue. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 3 figures. A total of 66 references are cited, including 20 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJT. 5 Issues raised: (1) The column should be minireviews; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
