2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a case control study of the diabetes complicated with hypertension by placental and serum levels of osteoprotegerin, interleukin and HGF in the third trimester of pregnancy. The topic is within the scope of the WJCC. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: This brief study is an</p>	[Y]

interesting study of the feasibility of changes in placental and serum protective factor, interleukin and HGF as tools for prediction and diagnosis of diabetes and hypertension in pregnant women. The study is well designed and the results are reasonable and well discussed. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 20 references are cited, including 20 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by Proof-Reading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Hainan Province Major Program of Science and Technology Projects 2017. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; and (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
