(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This manuscript is a narrative review on a very important and timely topic. The paper summarizes efficiently almost all the evidences in COVID19-related</p>	[Y]

liver disease. This discussion could be deeper, if the authors have further data (laboratory or clinical) in their institutions. A more detailed algorithm suggesting diagnostic tests to be performed and measures for monitoring liver damage in SARS-CoV2 infection should be made available. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 71 references are cited, including 60 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets
