(1) Classification: Grade B and Grade A; (2) Summary of the Peer-Review Report: The authors presented an interesting analysis of risk factors for predicting squamous cancer, and established a new prediction model. manuscript is well-written and the conclusions are clear. However, a key limitation of the paper is the use of a single data source for the derivation and validation cohorts, which should be explicitly stated that these findings will need to be replicated in a separate patient population. Further, the derivation and validation cohorts should be more clearly defined in terms of source, distribution and division. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 4 figures. A total of 14 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. 3 Academic norms and rules: The authors provided the Institutional Review Board statement, the Biostatistics Review Certificate, and the Informed consent statement. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the STROBE statement filled with page numbers in empty spaces after each item. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Medical Practice Income Plan (MPIP) grant from Texas Tech Health Sciences Center and National Science Foundation grant. The topic has not previously been published in the WJT. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved
