(1) Classification: Grade C; (2) Summary of the Peer-Review Report: These comparisons had been already discussed by a lot of surgeons, and currently,</p>	[Y]

fully-laparoscopic radical gastrectomy is recommended by skillful surgeons. This point should be discussed. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 9 figures. A total of 32 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by Spandidos was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Health Commission of Sichuan Province. The topic has not previously been published in the WJMA. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
