The topic is within the scope of the WJCO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This study is a population-based studies of mucoepidermoid CA of the major salivary glands including more than 2000 patients. of the study are already cited by the authors and we think that they did not affect the quality of the work. Discussion is well written and systematic; and (3) Format: There are 2 tables and 3 figures. A total of 40 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The Institutional Review Board Approval Form and written informed consent were waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Community Cancer Fund, Spokane, WA. The topic has not previously been published in the WJCO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the
