The topic is within the scope of the WJH. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors evaluate in their retrospective study the value of ERCP and liver biopsy in the assessment of increase in liver enzymes after liver transplantation. Overall, the manuscript is written well and the topic of interest. However, there are some issues should be addressed. CT or MRCP</p>	[Y]

can diagnose most of anastomotic stricture. ERCP is an useful method as a treatment modality for anastomotic stricture, but it might be over-invasive for a diagnostic modality alone. Authors should show the results of CT or MRI before ERCP. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 22 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Institute of Health. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please
