The topic is within the scope of the WJG. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: This is an exceptionally zealously searched and comprehensive review of the two rare disease entities, in particular, MGIST. The authors tried to establish definite diagnosis of MGIST since the different treatment</p>	[Y]

may be necessary for MGIST. From the 43 publications they studied, 12 patients with MGIST were identified among the potential 161 patients examined. It is an extensive survey. Please provide a table for overall description of patients at PKUPH before comparison. Please minimize duplication of contents of table in the text. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 67 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form.. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed
