within the scope of the WJG. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: This work describes an interesting issue. This is a well-written manuscript. However, it would need to be organized and structured differently. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 6 figures. A total of 53 references are cited, including 20 references published in the last 3 years. There are 7 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. I have changed the manuscript type “review” to “minireview”.

Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
