The topic is within the scope of the WJCCM. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: It is a well round review about SARS-CoV-2 pandemic and its effects on the morbidity and mortality of COVID-19 patients. Nevertheless, the authors need to</p>	[Y]

add some comments to clarify several issues like how severely ill patients develop end stage disease and die because of the virus. The authors also need to add specific considerations into other supports working in parallel with ECMO and improve the rationale for using ECMO in other critical respiratory failures. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 32 references are cited, including 29 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCCM. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) the author should put the in-text citations (superscripted) before the punctuation or after the cited author's name, with no spaces; (4)

	<p>please provide the audio core tip file where the content of core tip is recorded; and (5) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked and revised the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
