to clinical practice; and (3) Format: There are 2 tables and 2 figures. A total of 38 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Melody was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, written informed consent and the Institutional Review Board Approval Form. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Chang Gung Memorial Hospital and US National Institutes of Health. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents.
