A)Inclusion or exclusion criteria of rectally spared UC with regard to topical corticosteroid/mesalamine exposure B)Rationale for choosing 1:3 case: controls. Why not the entire cohort of UC for analysis? C)How many patients from the 24+72 completed 5 year followup or were excluded from analysis based on the inadequacy of follow-up? (3)Format: There are 2 tables and 3 figures; (4)References: A total of 20 references are cited, including 2 references published in the last 3 years; More recent references are required. (5)Self-cited references: There are 2 self-cited references (first author). The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e. those which are most closely related to the topic of the manuscript) and remove all other improper self-citations.
