The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors reported an interesting case report on a very rare presentation of metastatic liver tumour, which is exceedingly rare.</p>	[Y]

The manuscript is well written and the relevant question as to the possible mechanism for this is asked. However, the language needs minor revision. A better literature review should be added; and (3) Format: There are 3 figures. A total of 30 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND
