The topic is within the scope of the WJG, but it is more suitable for AIGC. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors present a review on the application of artificial intelligence in cases of gastrointestinal cancer. This is an interesting and appropriate topic. However, there are some aspects that could be improved. The questions raised by</p>	[Y]

	<p>the reviewers should be answered; and (3) Format: There are 6 tables and 1 figure. A total of 85 references are cited, including 65 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Medical English Service was provided. 3 Academic norms and rules: No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The column should be minireviews. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. I have changed the manuscript type “review” to “minireview”.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the Artificial Intelligence in Gastroenterology.</p>
