The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: It is an interesting case. However, there are some issues should be addressed. Language needs polishing. The authors need to add the follow-up of this case. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 19 references are</p>	[Y]

cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and surgical treatment informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
