The topic is within the scope of the WJCU. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors found an interesting manuscript reporting a rare case of bladder damage during a standard procedure. The manuscript is well done and the English is suitable. However, some words need</p>	[Y]

to be revised; and (3) Format: There are 4 figures. A total of 6 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors need to provide the CARE Checklist with page number, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors' information should list in the first page; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text,

	<p>according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
