2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: Recommend for rejection. Scientific classification: Grade C, Grade C and Grade D. Language classification: Grade B, Grade B and Grade B. Scientific classification does not meet the publication standard of WJG. This is the presentation of a clinical case showing the evolution of a patient with HBV infection after several drug treatments, and after partial hepatectomy secondary to</p>	[Y]

	<p>HCC development. However, some inconsistencies render this case presentation difficult to follow, and understand its relevance. The figures regarding histology don't show the described changes, and also there is no special staining for evaluating liver fibrosis. The resolution of fibrosis after antiviral therapy in HBV-infected patients has been reported previously and not so rare observation. Therefore, I suggest the Editorial Office director reject this manuscript.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: The title of the manuscript is too long and must be shortened to meet the requirement of the journal (Title: The title should be no more than 18 words). I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
