The topic is within the scope of the WJN. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors present two siblings, infected with COVID-19, in whom the outcome was the opposite of what was expected. While the cases(s) presented are interesting by itself, the manuscript is not written very clearly/fluently. The questions raised by the reviewer should be answered; and (3) Format: There is</p>	[Y]

1 table and 1 figure. A total of 25 references are cited, including 24 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The CARE Checklist-2016 lacks of the page number. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJN. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. The authors need to provide the signed treatment informed consent. The author should number the references in Arabic numerals according to the citation order in the text. The
