The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The article about Crohn's disease patients with specific complications/strictures, is very interesting. gastroenterologists, internal medicine specialists, surgeons and all physicians treating IBD patients. The authors should discuss/comment advantages and disadvantages when comparing the effectiveness of surgical or endoscopic methods of treatment compared to the described long-lasting therapy, which may be associated with side effects. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 39 references are cited, including 8 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and STROBE Statement. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation

	<p>numbers to the reference list and list all authors of the references. Please revise throughout; and (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I recommend the manuscript to be published in the World Journal of Gastrointestinal Endoscopy.</p>
