Peer-Review Report: It should be said that research on NLR and CA19-9 in the field of advanced pancreatic cancer is not uncommon. As a retrospective study, this article is a certain supplement to other similar studies. The article summarizes and analyzes the case characteristics of the author's medical center. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 3 figures; (4) References: A total of 36 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. The Biostatistics Review Certificate is not provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript.
