The topic is within the scope of the WJG. (1) Classification: Grade A, Grade B, Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: This is a good work, well presented and describes its methodological</p>	[Y]

development and results very well. However, there are some issues should be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 35 references are cited, including 20 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. No animals are involved in the study. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; and the Development Program of China during the 13th Five-year Plan. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the "article highlight" section.
