(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors have elegantly reviewed an enigmatic but important topic of mesenchymal stromal cells dependent immune regulation in drug induced liver failure by</p>	[Y]

summarizing animal models. The Table and Figures are very well made and with updated current literature. The manuscript is well written. However, the manuscript requires minor language and grammar/syntax corrections. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 2 figures. A total of 78 references are cited, including 17 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) The references’ number should be superscript; and (5) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list
