2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective study of the MVV and HALP predict ESCC survival. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The article explores an important field of preoperative evaluation of the</p>	[Y]

patients and links the patient's features to overall survival. However, there are some issues should be addressed. Limitation of the study is to ignore completely the postoperative complication and mortality rates. There are a few spelling errors. As stated for pulmonary surgery cited in literature, the association of the results with the incidence of complication is not mentioned, as well as this data of postoperative mortality is not explained in the overall survival rates. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 6 figures. A total of 37 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was performed with 5 financial supports. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval

	<p>document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section.
