The topic is within the scope of the WJG. (1) Classification: Grade C; (2)</p> <p>Summary of the Peer-Review Report: This article compared the</p>	[Y]

tolerability, efficacy and safety of split protocols of Moviprep and PrepKit-C in patients having a colonoscopy. And a subgroup analysis has been conducted for IBD patients and non-IBD patents. Since the colonoscopy and IBD has attracted more and more attention in the clinical practice, the article is interesting. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 27 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and

Please add the “Article Highlights” section at the end of the main text. 6</p> <p>Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked and revised the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
