observational study of the lymphadenectomy improves prognosis of T1b gallbladder cancer. The topic is within the scope of the WJG.

(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an interesting study. There are very few articles on the T1b stage and an important point has been made. However, there are some issues should be addressed. Have lymph node positive patients received adjuvant chemotherapy and radiotherapy? If lymph node positive patients did not receive chemotherapy, what is the reason? The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 20 references are cited, including 6 references published in the last 3 years. There is 1 self-citation.

2 Language evaluation: Classification: Grade A. A language editing certificate issued by SNAS was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and STROBE Statement. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was performed with 7 financial supports. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not
