The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This case of patient diagnosed with pheochromocytoma presenting with non-ST segment elevation myocardial infarction, heart failure and transient erythrocytosis with nonobstructed coronary arteries is very rare. The manuscript is very well written, and the case is described very detail. The</p>	[Y]

treatment of this patient is reasonable, and the follow up is good. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 41 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Science and Technology Support Plan Project of Chengde, China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
