Peer-Review Report: The authors reported an interesting and well written report. The paper is presented in a proper form. However, the English consistency of the manuscript should be checked. There are several grammatical and ortographical errors throughout the manuscript; and (3) Format: There are 4 tables and 2 figures. A total of 22 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 13% in the CrossCheck report. The authors need to rephrase the repeated parts. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China (NSFC), Beijing Natural Science Foundation and the China National Science and Technology Major Project for Infectious Diseases Control during the 13th Five-Year Plan Period. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author
