is 1 table and 4 figures. A total of 49 references are cited, including 3 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Charlesworth was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. No animals are involved in the study. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the "article highlight" section.
