*(1) Science editor: 1 Scientific quality: The manuscript describes a case report of the 17OHD from p.Tyr329fs homozygous mutation. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is an interesting case, and the manuscript is well written; and (3) Format: There are 2 tables. A total of 28 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors need to provide the CARE Checklist-2016, and surgical treatment informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited/invited manuscript. The study was supported by the Anhui Province Key Clinical Specialist Construction Fund; and Anhui Province Central Guided Local Science and Technology Development Funding Project. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure*

*that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout;*

**Response:** The CARE Checklist–2016 and surgical treatment informed consent had been provided. Noted that there were three cases in this case report and we only provided the case 1’s surgical treatment informed consent because of case 2 did not receive the surgery in our hospital and case 3 did not receive the surgery. Meanwhile, the approved grant application forms have been attached with this response. As required, original figures have been provided with this manuscript. Figures have been prepared using PowerPoint as recommended. We have updated the reference list to include the PMID and DOI for all the citations where these were available. However, PMID and DOI were not available for certain references, such as those that are not published in English, or chapters in a book. For these references, we did not provide the PMID and DOI.
