information was provided, and the case is very interesting. Both the quality and quantity of images are nice. However, there are some issues should be addressed. The authors performed also the IHC staining regarding CMV infection. The reviewer thinks that an additional iconography, reporting the IHC images of CMV positivity, could be appreciated in order to increase the soundness of manuscript. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 14 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by ATS was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation
