2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 <b>Scientific quality:</b> The manuscript describes an observational study of the real-world disease activity and sociodemographic, clinical and treatment characteristics of moderate-to-severe inflammatory bowel disease in Brazil. The topic is within the scope of the WJG. (1) <b>Classification:</b> Grade C; (2) <b>Summary of the Peer-Review Report:</b> The authors reported a well-written manuscript about the correlation between disease activity and sociodemographic characteristics in Brazil. However, the questions raised by the reviewers should be answered; and (3) <b>Format:</b> There are 3 tables and 1 figure. A total of 43 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 <b>Language evaluation:</b> Classification: Grade A. A language editing certificate issued by AJE was provided. 3 <b>Academic norms and rules:</b> The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The STROBE Statement lacks of the page number. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 8% in the CrossCheck report. The authors need to rephrase the repeated parts. According to our policy, the single-source similarity</p>	[Y]

	<p>should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
