(1) Classification: Grade C; (2) Summary of the Peer-Review Report: In the present study, authors performed a randomized controlled trial study for investigating the effect of consumption of powder containing probiotic *Lactobacillus plantarum* Dad-13 on gut microbiota and intestinal health of overweight adults. Overall, it is a complete study with some interesting findings; and (3) Format: There are 9 tables and 5 figures. A total of 49 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors provided the Biostatistics Review Certificate, Clinical Trial Registration Statement, the Institutional Review Board Approval Form and Written Informed Consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Ristekdikti Kalbe - Science Awards. The topic has not previously been published in the WJG. The corresponding author has one published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please

prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (6) please don’t include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters.
