The topic is within the scope of the WJD. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The study could lead to significant findings and clinical application. However, a negative result adds little to our</p>	[Y]

current knowledge. The sample size is small. The result might be different if the authors look at more patients. Too many confounding factors. The inclusion/exclusion criteria were loosely defined. Diet, drugs, occupations, close contacts and family members can all have potential influences; and (3) Format: There are 2 tables and 1 figure. A total of 31 references are cited, including 18 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The authors need to provide the Signed Informed Consent and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJD. The corresponding author has 1 published article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (3) Please write the "Conclusion" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally
