The topic is within the scope of the WJG. (1) Classification: Grade C and D; (2) Summary of the Peer-Review Report: Reviewer 02259896 pointed out that this study was interesting and the overall results and interpretations of the experiments were appropriate, but the authors should address the some concerns. Reviewer 02441467 pointed out that the idea of this paper was relatively complete, focusing on the</p>	[Y]

effect of miR-34a demethylation on the biological function of liver cancer cells. However, the authors needed to make a major revision according to the comments; and (3) Format: There are 6 figures and some supplementary figures. A total of 33 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and B. The authors provided the Non-Native Speakers of English Editing Certificate. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form and Biostatistics Review Certificate. No academic misconduct was found in the CrossCheck detection and the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The "ARTICLE HIGHLIGHTS" section is missing. Please write this section at the end of main text; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
