2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireviews of the frailty, sarcopenia and cachexia in heart failure patients. The topic is within the scope of the WJC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript is a well-written mini-review covering clinically important aspects of cachexia, sarcopenia and frailty in patients with heart failure. It bears significance and innovation. However, some references should be cited in the manuscript. The questions</p>	[Y]

raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 65 references are cited, including 10 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The reference's number should be put in the square brackets; and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor.
