The topic is within the scope of the WJH. (1) Classification: Grade B, B, D; (2) Summary of the Peer-Review Report: It is a well written review paper on liver regeneration. The authors need to include how gender, hormones and ethnicity would affect the outcomes of liver</p>	[Y]

regeneration; and (3) Format: There are 2 figures. A total of 145 references are cited, including 77 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, B, C. The authors provided the AJE editing certificate. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. This study obtained the support from Russian Academic Excellence Project "5-100" for the Sechenov University. The topic has not previously been published in the WJH. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. And (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
