2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1 Scientific quality:</b> The manuscript describes a basic study of the Xiangbinfang granule enhancing gastric antrum motility via intramuscular interstitial cells of Cajal in mice. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a very interesting study. However, substantial revision is needed to</p>	[Y]

increase the value of the paper. The authors should discuss more the interactions between vagus and intramuscular interstitial cells of Cajal and migrating motor complex (MMC). The authors should compare their results with two other studies in rats, and expand on the description of the MMC. Further, key results should be explained in more details. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 33 references are cited, including 6 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade C. A language editing certificate issued by BPG Editing was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form, the ARRIVE guidelines, and the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Specific Research Fund for TCM Science and Technology of Guangdong Provincial Hospital of Chinese Medicine and National Regional Traditional Chinese Medicine (Specialist) Clinic Construction. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant

application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI to all references in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (5) the in-text citation numbers in square brackets need be superscripted at the end of the sentence before the punctuation or after the cited author’s name, with no spaces; (6) please don’t include any \*, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted).
