The topic is within the scope of the WJG. (1) Classification: Grade C</p>	[Y]

and Grade C; (2) Summary of the Peer-Review Report: It is an interesting article. The methodology is adequate and consistent with the objective of the study, and the results support the discussion. However, the authors should include discussions on the following topics including oxidative stress and the expression and activity of the transcription factor Nrf2, Nrf2 modulation and NF- $\kappa$ B activity, and linkages between the molecular changes and the prevention of mitochondrial dysfunction. The figures need revision. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 6 figures. A total of 56 references are cited, including 14 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Animal Care and Use Committee Approval Form or Document, the Biostatistics Review Certificate with statement that the biostatistical methods are appropriate, and the ARRIVE Guidelines with page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Deanship of scientific research and Research Center at King Saud University. The topic has not previously been published in the WJG. The corresponding
