2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a review of the hepatic angiomyolipoma. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The paper represents a literature review on a rare clinical entity, hepatic angiomyolipoma (HAML). The authors summarize the clinical characteristics of</p>	[Y]

patients with HAML and propose a pragmatic approach for management of HAML. This review can serve as a good resource for providers encountering patients with HAML with no to general experience on this topic. However, the title should be expanded to represent the content and the type of the study. The introduction should be expanded. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 62 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The reference number should be superscript; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
