The topic is within the scope of the WJCCM. (1) Classification: Grade C; and (2) Summary of the Peer-Review Report: The article needs to be edited by a native English speaker. "Both techniques, though, are invasive, costly and require bulky equipment, which renders their usage in daily clinical practice." The reviewer cannot understand what the author wants to say. chronically ill patients, condition improves” needs to be rewritten for more clarity. A total of 12 references are cited, including 5 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The author need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited/invited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJCCM. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C. Please provide the author contributions; and (3) I found the authors did not add the PMID and DOI in the reference list. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
