The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Although this study contains merit for advancing the therapy of gastric</p>	[Y]

cancer, there are several problems that should be revised before publishing. The result, discussion and conclusion need to be modified. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 36 references are cited, no reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; Nature Science Foundation of Zhejiang province, China; The hygiene department of Zhejiang. The topic has not previously been published in the WJG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for
