2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the expression of notch pathway components in colorectal tumors. The topic is within the scope of the WJCC. (1) Classification: Grade D, Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: The paper is good and well written. However, the discussion, introduction and other aspects need to be modified,</p>	[Y]

and the language also needs to be improved. The questions raised by the reviewers should be answered; and (3) Format: There is no figure and table. A total of 31 references are cited, including 11 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B, Grade A, Grade B and Grade B. A language editing certificate was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS" section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
