**Comment:** Abstract, line 13: slected Core tip: "...discuss a select..."

**Comment:** Abbreviations: Sj?gren'

**Comment:** Page 8, Introduction: The number of listed disorders in Table 2 is 61, not 65.

**Comments from Reviewer 2:**

**Comment:** The author reviewed the relationship between H pylori infection and autoimmune diseases. Although most animal models of autoimmune diseases do not rely on H. pylori infection for the induction of the disease or do not provide data to support that this pathogen is needed for disease’s development. So most of the mechanisms discussed in the literature remain hypotheses that require more extensive investigation. However, the author suggested the current evidence in support or against the role of H. pylori as a potential trigger of autoimmune diseases, as well as discussed selected autoimmune conditions, both organ specific and non-organ specific, which have an evidence base (positive or negative) in relation to H. pylori infection. I think this review is very interesting and also provided helpful hints for future research.
