The manuscript's title, abstract and introduction were crispy and informative. Kindly do some important changes in your manuscript. The authors should also elaborate the precipitating factors and pathogenesis of pustular psoriasis. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 8 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist, and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by funding from the Ministry of Science and Technology of China; and Hubei natural science foundation. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME
