The topic is within the scope of the WJGS. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: In this manuscript, the authors reported the remnant GC had similar clinicopathological</p>	[Y]

characteristics and prognosis to primary PGC. This manuscript is well written. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 38 references are cited, including 12 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGS. 5 Issues raised: (41) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
