However, the Introduction section should be revised as suggested. In RBV CLINICAL PHARMACOLOGY section, more references should be referred</p>	[Y]

to; and (3) Format: There are 7 tables. A total of 223 references are cited, including 52 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Filipodia Publishing, LLC was provided. 3 Academic norms and rules: The authors provided the PRISMA 2009 Checklist. The Biostatistics review certificate was waived due to no such involvement in the manuscript. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (2) the author should number the references in Arabic numerals according to the citation order in the text. The in-text citation numbers are not sequential. Please revise through; (3) please don’t include any *, #, †, \$, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; (4) please write the “Conclusion” section at the end of the main text; (5) please provide an audio core tip file where the core tip content is recorded; (6) please include subheadings of “MATERIALS AND METHODS” and “RESULTS” in the main texts according to journal requirements; and (7) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. 6
