(1) Classification: Grade A; (2) Summary of the Peer-Review Report: A systematic review with meta-analysis on this topic has not yet been published, which gives it a high scientific value for readers. revised in the abstract, phrase and the adoption of the article. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 10 figures. A total of 49 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by MogoEdit was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the PRISMA 2009 Checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 6%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Natural Science Foundation of Gansu Province, China; Gansu Da Vinci robot high-end diagnosis and treatment team construction project and National Key Research and Development Program and Lanzhou Science and Technology Plan Program; Northwest high incidence characteristic malignant tumor prevention and control suitable technology management platform set up and demonstration applications; GM-CSF and let-7b promote gastric cancer metastasis and drug resistance.
