2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the negative lymph nodes/tumor size in rectal cancer. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors suggest a potentially novel prognostic score to stratify risks for rectal cancer patients. The general idea is very interesting, however, it is totally unclear why this analysis is restricted to rectal cancer, the remaining colon would deliver an ideal either additional</p>	[Y]

or control group. The study need to cite a suited work to proof that the relative degree of LND can be quantified by comparing pure numbers of dissected LNs with the tumor size. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 5 figures. A total of 22 references are cited, including 10 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the STROBE Statement. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Cooperative Fund of Nanchong Government and North Sichuan Medical College. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure
