2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of a prognostic model for patients with hepatorenal syndrome. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B, Grade B, Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a very interesting study on development and validation of a novel prognostic score named GIMNS for patients with HRS. there are some issues need to be addressed. The finding of MCHC may be a statistical aberration rather than a true biological predictor of HRS, as firstly the reason behind its association is unclear, and its pathogenic role is even more doubtful. Secondly, the hazard ratio is the smallest of the 5 factors, and in absolute number it is also small. The authors should highlight the clinical importance of the conclusions. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 5 figures. A total of 20 references are cited, including 10 references published in the last 3 years. There is one self-citation. 2 Language evaluation: Classification: Grade A, Grade A, Grade A, Grade B, Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. The authors need to provide the informed consent, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Chinese High Tech Research & Development (863) Program. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the
